**1.01** <u>Establishment of Quorum</u> - The special school board meeting was called to order at 3:00 p.m. at the school district office. A quorum was established with Directors Barbara Bevens, T.J. Heller, John Kurtz, and Brian Moore.

- 2.01 Interviews to Fill the Board Vacancy for School Board Director Position #1 (Interviews) The board interviewed candidates for position #1, vacated on July 31, 2024, by Sarah Werling-Sandwith. This was a public meeting for a formal interview process. The successful candidate was to fill the board vacancy until the term ending in November, 2025. The interviews for a replacement board member took place at the following times:

Each board member asked pre-determined questions, in turn. A short break was taken between 3:18 pm and 3:21 pm.

**2.02** Executive Session as per RCW 42.30 110(h) 3:41 pm – 3:58 pm (Action) – After the interviews, at 3:41 pm, the board recessed into executive session for 15 minutes (until 3:56 pm) in accordance with RCW 42.30.110(h), to evaluate the qualifications of candidate for appointment to elective office. At 3:56 pm Board Chair Bevens requested an additional 2 minutes. At 3:58 pm the board re-convened into public session. No action had been taken during the executive session.



**2.03** <u>Selection of New Board Member</u> (Action) – The board reconvened after the executive session. Director Kurtz moved to nominate Melanie Hess to fill the position #1 vacancy on the board. Director Bevans seconded the motion. The board roll call vote was as follows:

Director Moore – abstained Director Heller – nay Director Kurtz – aye

Director Bevens - aye

The board vote was in favor of Ms. Hess as Board Director #1. Ms. Hess accepted the position. Ms. Hess will be sworn in at the next regular board meeting, September 25, 2024.
