2.01 Superintendent's Report (Information) - Superintendent Woods shared that there will be upcoming events including the board retreat on August 9th and 10th in which Sandy Hayes will conduct a training with the board on self- evaluation, board goals, and superintendent evaluations as well as the AVID conference the last week of July. There have not yet been any Department of Health updates regarding COVID and the start of the school year; however, updates are expected in August.

Furthermore, Superintendent Woods applauded the high quality art program offered by teacher Andrew Anderson.

- **3.02** Monthly Budget and Enrollment Report (Exhibit) (Information) Finance Director José Domenech presented to the Board the Monthly Budget Report through June 2022. The board discussed the future QZAB bond balloon payment and different ways of paying for it.

The Public Hearing was closed at 5:10 pm. Director Kurtz moved for approval of the resolution. Director Heller seconded the motion. The board vote was unanimous.

4.02 Additional Director Reports (Information) - Director Heller spoke about topics to bring to the August 19th meeting with Legislators at Anacortes ESD including lifting the levy lid and regionalization. He shared that Orcas, Lopez, and San Juan Island board members have been working together to prepare for the meeting and have discussed the possibility of cooperatively hiring a lobbyist in the future to work for beneficial changes. Director Heller opened the topic about the two recent Supreme Court rulings on prayer at school and using federal funding to access private religious schools could impact San Juan Island School District.

4.03 Approval of 2022-2023 Board Calendar (Exhibit) (Action) - The Board was requested to review and approve the proposed board calendar for school year 2022-2023. The Superintendent recommended approval of the 2022-2023 board calendar as presented. Director Kurtz moved for approval of the board calendar. Director Werling-Sandwith seconded the motion.
